RULES OF CONDUCT

The adult administration of the Hidden Lakes Teen Patrol (HLTP) and the Keller Police Department welcomes your participation in the Hidden Lakes Teen Patrol Program. You should be aware that the nature of this voluntary duty could sometimes be tense. In the interest of effective patrolling and your own safety, you will comply with the following regulations:

1. Individuals must be at least 15 years of age and sign a waiver (parent(s) must also sign). An application packet must be completed and turned into the HLTP administration or the Keller Police Department representative prior to assignment duties. Six hours of training with the Keller Police Department must be completed before actual duty assignment.
2. You will not consume any alcoholic beverages or other intoxicants prior to your duty, nor will you report under the influence of any alcoholic beverages or intoxicants.
3. You will not carry a firearm or a weapon prohibited by Texas or federal law. If you are found to be armed, the patrolling period will be terminated and you are subject to arrest for violation of applicable law.
4. You will convey to no person, by acts or statements, that you are a police officer or have the powers and authority of a police officer.
5. You will refrain from involving yourself in any physical struggle or verbal arguments with any persons encountered.
6. You will not become involved in any police investigation or discuss any investigation with another citizen. You will not make known to any unauthorized person the identity of person suspected of or arrested for any offense, nor will you reveal the identity of any persons detained by police for any reason.
7. You will remain in your assigned patrol area (Hidden Lakes Addition) the entire duration of your observation period unless your conduct is determined to impair effective patrol operations, in which event your observation period will be immediately terminated.

WAVIER OF LIABILITY
RELEASE, INDEMNIFICATION
AND HOLD HARMLESS AGREEMENT

THE STATE OF TEXAS
COUNTY OF TARRANT

That I, _____, the undersigned, a private person, for and in sole consideration of the privilege of riding as a patrol individual in the Hidden Lakes Teen Patrol (HLTP) in the City of Keller, Texas, during the period of acceptance into the program beginning in the year 20__ and recognizing that routine patrol activity involves occasional risks to persons and property, do hereby agree to assume the risks and any unexpected dangers attendant to such activity, including but not limited to property damage and/or personal injury to me as a result of motor vehicle accidents or motor vehicle collisions on either public streets or private property; property damage and/or personal injury to me as a result of citizen contact; property damage and/or personal injury to me resulting from the acts of third parties whether caused by, errors, omissions, or negligent acts of third parties or myself; property damage, and/or personal injury to me resulting from my own activities, errors, omissions, or negligent acts of third parties or myself; property damage and/or personal injury to others resulting from my own activities, errors, omissions or negligent acts.

I do hereby waive all claims, release, indemnify, defend and hold harmless the City of Keller and the Hidden Lakes Homeowners all of its officials, officers, agents, employees, in both their public and private capacities, from any and all liability, claims, suits, demands, expenses of litigation or causes of action which may arise by reason of injury to persons or loss of, damage or loss of use by any property occasioned by error, omission or negligent act of myself or any other persons with regard to this agreement, and I will, at my own cost and expense, defend and protect the City of Keller and the Hidden Lakes Homeowners against any and all such claims and demands.

I do hereby further agree to indemnify, defend and hold harmless the City of Keller and the Hidden Lakes Homeowners, all of its officials, officers, agents, employees, from and against any and all claims, losses, damages, causes of action, suits and liability of every kind, including all expense of litigation, including but not limited to court cost and attorney fees for death, injury to or debt of any person or for loss, damage to or loss of use of any property arising out of or in connection with this agreement. Such indemnity shall apply whether the claims, losses, damages, causes of action, suits or liability arise in the whole or in part from the negligence of the City of Keller or the Hidden Lakes Homeowners, its officers, officials, agents or employees. It is the express intention of the parties hereto, both myself, the Hidden Lakes Homeowners and the City of Keller, that the indemnity provided for this paragraph is indemnity by the undersigned to indemnify and protect the City of Keller and the homeowners in the Hidden Lakes Subdivision from the consequences of the City of Keller's own negligence, the Hidden Lakes Teen Patrol's own negligence, whether that negligence is the sole or concurring cause of injury, death or damage.

It is further agreed that the execution of this Waiver of Liability, Release, Indemnification and Hold Harmless Agreement will not constitute a waiver by the City of Keller or the homeowners of Hidden Lakes of the defense of governmental immunity (applies only to the City of Keller), or any other defense recognized by the courts of the State of Texas.

I, the undersigned have read the waiver of liability, release, indemnification and hold harmless agreement and understand its terms. I execute it voluntarily and with full knowledge of its significance.
